**Note-II:** As per the Revised Recruitment Rules for Academic Staff – 2019 dated July 01, 2019 of IIIT – Naya Raipur, the Institute follows 4-tier flexible faculty structure and all the posts are to be filled-in by open advertisement. Thus, candidates working at IIIT-Naya Raipur who are aspiring for higher AGP/cadre and possessing eligibility criteria are also required to submit their application.

**Note-III:** For the departments which are not having any vacancy, movement in higher Pay Level or cadre will be carried out as per specified selection process but restricted to only for serving faculty members of the respective departments of the Institute subject to fulfilling the eligibility criteria.

## (C) Benefits Provided

The Institute makes every attempt to help faculty members settle fast in their academic role and grow professionally. It offers a number of benefits to faculty members, which include:

- 1. Contribution towards New Pension Scheme (NPS), Leave Travel Concession (LTC), Transportation allowance, Education allowance for children, Medical re-imbursement, Reimbursement of relocation expenses, Re-imbursement of telephone bills, etc. as per the Institute policy.
- 2. A Cumulative Professional Development Allowance (CPDA) of Rs. 3 Lakhs for every block period of 3 years is available to every faculty member to meet the expenses for participating in both national and international conferences, paying the membership fees of various professional bodies, books and periodicals, contingent expenses, and other professional development activities.

## (D) <u>Instructions and Other Terms and Conditions</u>

- 1. Allowances, age relaxation and other terms and conditions of service are as decided by the Institute from time to time, subject to directions/guidelines of the State Government.

Faculty members from other academic institutions or scientists/researchers from R&D organizations having requisite qualification may also apply for appointment on deputation, the initial period for which would be 1 year, extendable based on performance and mutual consent of the two institutes/organizations. Such applicants should submit a letter from their employer mentioning that they will allow the candidate to undertake this assignment, if selected.
- 3. Applicants who are employed in Government, Semi-Government, Autonomous Body or Institution should send their applications through proper channel. They will be required to produce the No Objection Certificate from their employer at the time of interview.
- 4. The candidates selected, shall be appointed on probation for two years.
- 5. The Institute reserves the right to fill or not to fill any or all positions.
